# Cookies Policy

## 1. Introduction

- 1.1. This Cookies Policy is entered by and between Fivehills Securities Limited (referred to as 'we', 'us', 'our', 'ours', 'ourselves' and 'the Company') and the Client (referred to as the 'Client', 'you', 'your' and 'yourself').
- 1.2. When you use our Website, we will use cookies to distinguish you from other users of our Website. This helps us to provide you with a more relevant and effective experience when you browse our Website, including presenting websites according to your needs or preferences and it allows us to improve the site generally.
- 1.3. All websites that operate across certain parts of the European Union are required to obtain consent when using or storing cookies on your computer or mobile device. ## 2. What is a cookie?

- 2.1. Cookies are small pieces of information which are stored as text files on your device: computer, laptop, tablet or smartphone, when you visit an internet website utilizing them. Cookies are not harmful to those devices. They are designed to hold very small amounts of data specific to you and to track your movement around our Website so that we can tailor the website for your preferences to make each visit a better experience. We allow technology partners to set cookies, to determine things such as the type of device being used, as well as third party advertisers to tailor content for marketing purposes.



2.2. The cookies do not contain personally identifying information nor are they used to identify you. You may choose to disable the cookies. However, you may not be able to access some parts of our Website if you choose to disable the cookie acceptance in your browser, particularly the secure parts of this Website.

#### 4.4. Third party cookies

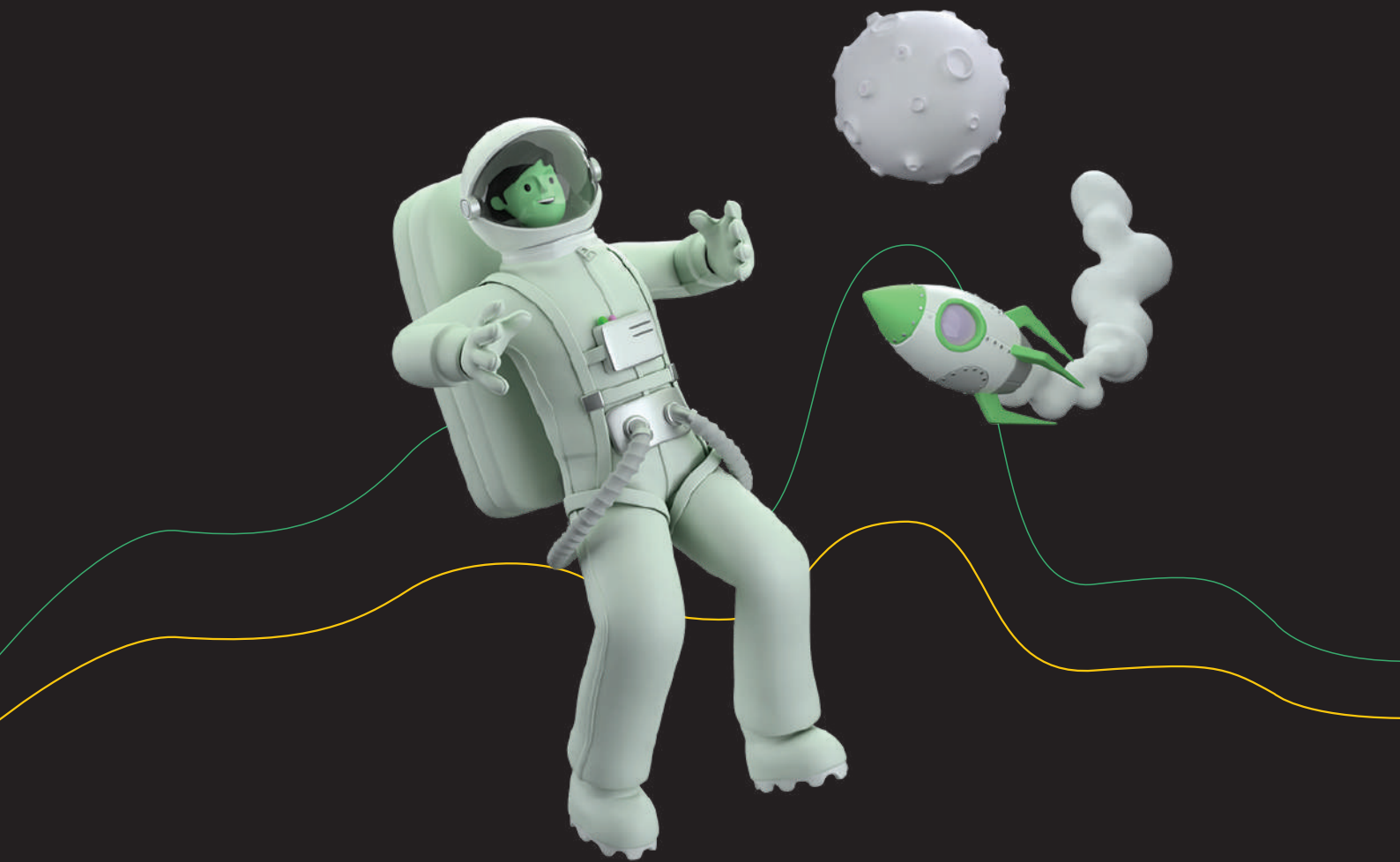
